AFFIDAVIT

I, ERICK ARONN THEODORUS RUOH, 31 years old (DOB: April 22, 1994), single, a resident of Block E3 No 3A Semarang Indah, Semarang City, Indonesia, and presently residing at Jazz Residences Jupiter St Makati City, currently employed as Customer Service (Information Technology) at Alpha Philindo Company located at 2nd Flr. 134 Building Jupiter St Brgy. Bel-Air Makati City, after having been sworn to in accordance with the law, do hereby depose and states THAT:

- 1. I hereby request protection from the Government, especially from the Embassy of Indonesia, for my safety during the process of my return to Indonesia. I am currently working in Makati, the Philippines, as a CSIT staff member at an online gambling game company called Alpha Philindo. I am deeply concerned for my safety and the safety of my family, but I have gathered the courage to reveal everything that has happened within the company where I work.
- This company operates numerous online gaming websites-not just hundreds, but thousands-targeting Indonesia and various other countries. The company provides website services for anyone who wishes to operate an online gambling platform.
- 3. In the CSIT department in Makati, there are around 14 Indonesian workers, but there are even more Indonesians in other departments. The company works with many game providers and maintains extensive connections. This is what makes me very concerned for my safety. I fear that they may have connections with the government, immigration, or even the police.
- 4. I am extremely worried about the safety of myself and my family. Should further information about this company be needed in the future, I am willing to cooperate as long as my safety is guaranteed.
- I would like to express my sincere gratitude for all the support and assistance provided by the Legazpi City Police and the Immigration Office in Legazpi City.
- 6. I executing this affidavit to attest the truthfulness of the foregoing facts and circumstances to the best of my knowledge and belief.
